## Celebrity Cruises Competition | MasterChef Competition

### Terms and Conditions

1. Information on how to enter forms part of the terms of entry. Entry into the Celebrity Cruises Competition | MasterChef Competition ("Competition") is deemed acceptance of these terms and conditions.

### Eligibility to Enter

Entry is open to all residents of Australia 18 years and older. However, employees and the immediate families of Network 10 Pty Limited (the "Promoter") or Celebrity Cruises and their associated agencies and companies or any organisation or individual associated with the provision of the prize(s) are not eligible to enter. Entrant must be residing in Australia at the time of entry, or their entry may be deemed invalid.

### Competition Period
