

# Network 10

## Studio 10 | Kids News Competition

### Terms and Conditions

1. Information on how to enter forms part of the terms of entry. Entry into the Studio 10 Kids News Competition ("Competition") is deemed acceptance of these terms and conditions.

### Eligibility to Enter

2. Entry is open to all residents of Australia between six (6) to twelve (12) years of age at the time of entry. However, employees and the immediate families of Network 10 Pty Limited (the "Promoter"), News Limited ("News Ltd") and their associated agencies and companies or any organisation or individual associated with the provision of the prize(s) are not eligible to enter. Entrant must be residing in Australia at the time of entry, or their entry may be deemed invalid.
3. Entrants under 18 years of age must have the prior approval of their parent or guardian to enter.

### How to Enter

6. To participate in the Competition entrants must
  - a. Log on to [www.10daily.com.au/win](http://www.10daily.com.au/win) and register their details including (but not limited to) name, address, phone number, email address, gender and date of birth.
  - b. Upload a video of your best News Reader performance demonstrating that you are Australia's best news reader (aged between six (6) and 12 years old). The video must not exceed 30 seconds and must not be greater than 30 mb.
  - c. By ticking the mandatory check box, agree that your parent or legal guardian gives approval for you to enter.
  - d. It is recommended that a parent or legal guardian may assist the entrant with their entry.

8. Incomprehensible and incomplete entries will be deemed invalid.
