## Melbourne Fashion Week | 10 Competition

#### **Terms and Conditions**

1. Information on how to enter forms part of the terms of entry. Entry into the Melbourne Fashion Week | 10 Competition ("Competition") is deemed acceptance of these terms and conditions.

## **Eligibility to Enter**

2. Entry is open to all residents of Victoria aged 18 years and over. However, employees and the immediate families of Network TEN Pty Limited (the "Promoter") and their associated agencies and companies or any organisation or individual associated with the provision of the prize(s) are not eligible to enter. Entrant must be residing in Australia at the time of entry, or their entry may be deemed invalid.

#### **How to Enter**
