# Experience 10 | 10 play Competition

### **Terms and Conditions**

1. Information on how to enter forms part of the terms of entry. Entry into the Experience 10 | 10 play Competition ("Competition") is deemed acceptance of these terms and conditions.

## **Eligibility to Enter**

- 2. Entry is open to all residents of Australia, aged 18 years old and over.
